My goal is to help lead the council back to its core responsibilities - reducing rates, proper road maintenance, reducing council overheads, maintaining waste services and protecting our local environment. The council should focus on serving the community, not expanding bureaucracy. The Central Coast Council has 2487 staff while the Sunshine Coast Council has 1847 staff, despite having a similar population size. This staffing difference of 640 employees costs the Central Coast an extra \$35 million annually. A working committee should be established to independently analyse these disparities and explore how the Central Coast Council can achieve the same efficiencies as the Sunshine Coast Council for the benefit of its ratepayers.
